DATE OF OPENING BIDS: Bids will be received at the Front Counter of the Livermore Area Recreation and Park District Building, located at 4444 East Avenue, Livermore, California, 94550, and shall be dated and time stamped by the District's Front Office before 1:00 p.m. on August 10th, 2022, at which time they will be opened and read aloud. Bids shall be submitted in sealed envelopes marked on the outside "Robertson Park Arena Infrastructure Improvement Project, #4918-729A".

LOCATION OF THE WORK: The work to be constructed hereunder is located at the site listed above, in Livermore, CA, in the County of Alameda, California.

DESCRIPTION OF THE WORK: The Work is more specifically defined in the Contract Documents, but is generally described as, but not limited to: seismic upgrade and repair of arena structure roof, new concrete flatwork and new guardrails and handrails. Please refer to the enclosed Bid Books, Improvement Plans, Structural Engineering calculations packet, & Geotechnical Memorandum.

PRE-BID WALKTHRU: A NON-MANDATORY Pre-Bid Meeting followed by a walk through at the Robertson Park Arena will be held at the LARPD Capital Improvement Projects Division, 4444 East Avenue, Livermore, California 94550 on the following date and time: 1:00 P.M. local time on June 28th, 2022.

Prospective bidders are urged to attend the Pre-Bid Conference. Prospective bidders may visit the Project Site without making arrangements through the District.

CONTRACTOR'S LICENSE CLASSIFICATION: The successful bidder must possess a current Class A, or Class C27 & C29 Contractor's License issued by the State of California and must be licensed from contract award through Contract completion.

Re. Bid Item 9 (Arena Roof: Structural Upgrades): Contractors and/or their sub-contractors are required to be licensed in the State of California, and have AISC (American Institute of Steel Construction) and AWS (American Welding Society) certifications. They should possess at least 5 years of experience in the proposed construction. All field welding is to be performed by certified welders and inspected by a Special Inspector as detailed out in the Contract Documents. The contractor will also be responsible for coordinating and submitting the completed Special Inspections Packet to the City of Livermore as needed.

CONTRACT DURATION: All of the Work for this Contract shall be substantially completed within 40 calendar days or sooner after the commencement, in accordance with the terms of the Agreement.

WAGE RATE REQUIREMENTS: The successful bidder will be required to pay the prevailing wage rates in effect on the date of this Notice, pursuant to California law, including California Labor Code Sections 1770, 1773, 1773.1,1773.6 and 1773.7 as amended. Copies of the prevailing wage rates are on file at the District Office, and shall be made available to any interested party upon request.

SUBSTITUTION OF SECURITIES: District will permit the successful Bidder to substitute securities for retention monies withheld to ensure performance of Contract, as set forth in Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention), in accordance with California Public Contract Code, Section 22300. By this reference, Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention) is incorporated in full in this document 00100.
