1. Call to Order

3. Approval of the Minutes of the Facilities Committee Meeting held on May 6, 2021

The minutes of May 6, 2021 were approved unanimously.

4. E-Bikes

Community Services Manager Jill Kirk presented to the Committee a report on E-Bikes. Currently, Ordinance 8 states E-Bikes are prohibited at Sycamore Grove Park and Holdener Park. With E-Bikes becoming increasingly popular, staff would like to amend Ordinance 8 to add a process for the use of E-Bikes at all LARPD parks and trails. The Committee and staff held a discussion on the details of the process to include allowing only class one and class two E-Bikes, with a limit speed of 15 MPH, at all LARPD parks and trails. The speed limit would apply to other types of vehicles as well.

The recommendation from the Committee is for staff to provide an educational campaign that will include speed enforcement and trail etiquette. The proposed program will be presented to the Program Committee before it is presented to the Facilities Committee.

5. Trail Connectors

Community Services Manager Jill Kirk provided an update on the trail connectors plan to the Committee. Staff reviewed the 2016 master plan that has specific trail connection recommendations. Staff will review what has been accomplished and will prioritize what needs to be completed. An update will be brought back to the Committee for review.

This item was discussion only and no committee recommendations were made, nor action taken.

6. CIP Updates-Current and Future Projects

General Manager Mat Fuzie presented the list of Project Evaluation Forms (PEF). Staff and Committee Members discussed that the PEF tracking form and related CIP Project Update form will need to be revised and merged into one document.
