1. **CALL TO ORDER:** Chair Pierpont called the meeting to order at 6:03 p.m. All Directors were present. Chair Pierpont welcomed members of the public and introduced the Directors, District staff, a City official, and officers from the Livermore Police Department.
2. **UPDATE ON CURRENT LARPD PROJECTS:**
PFM Haldeman provided updates on several District projects, including the Playground Replacement Program, the new Sunken Gardens Pump Track, the Sycamore Grove Amphitheater, the William "Bill" Payne Park Expansion Project, and the implementation of MaintainX maintenance management software. PCM Weisgerber provided an update on the Sport Stack Pilot Program. The first Sport Stack was installed at Jack Williams Park.
3. **JACK WILLIAMS PARK FEEDBACK:** A member of the public asked how the Sport Stack Pilot Program was communicated. Staff responded that LARPD shared information through press releases, social media, and newsletters.
4. **QUESTIONS FOR LIVERMORE POLICE DEPARTMENT:**
Sergeant Lendman and Officer Clayton answered public questions about e-bike regulations, reporting, e-bike safety education, and emergency evacuation procedures and communications.

The Livermore Police Department announced an E-Bike Safety presentation on August 25, 2026, from 5:00 p.m. to 6:00 p.m. at the Civic Center Public Library.

GM Fuzie referred the public to California Department of Forestry and Fire Protection (CAL FIRE) website for current detailed wildfire information and resources.

5. QUESTIONS FOR LARPD BOARD AND STAFF:

- a) Sunken Gardens Pump Track: A member of the public asked whether LARPD would consider adding additional features near the Sunken Gardens Pump Track. PFM Haldeman provided his contact information for further discussion.
- b) South Livermore Valley Trail T10 Extension: A member of the public asked about the Lake A/CEMEX Trail connection. Staff reported that LARPD is coordinating with Zone 7, the City of Livermore, and CEMEX on the trail connection and easement process.
- c) Open Space Evacuation Procedures: Members of the public asked about LARPD's evacuation procedures for open space parks and trails. Staff reported that LARPD has an evacuation process in place and coordinates with the Livermore Police Department and other agencies.
